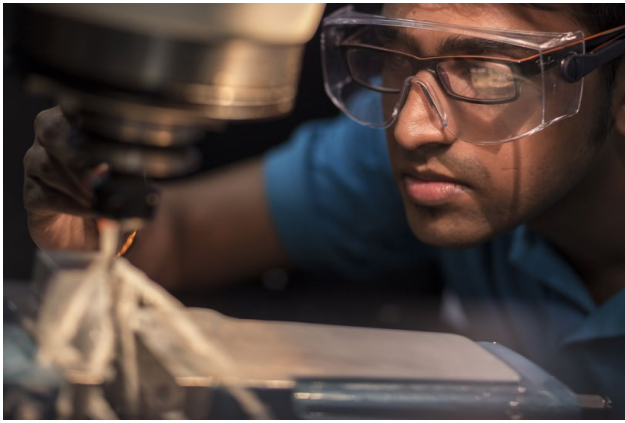

The SUTD-SMU DDP is a uniquely enriching learning experience: you will study and participate in student life activities at both campuses, gain global exposure via exchange programmes and overseas learning opportunities, complete 80 hours of community service, and be prepared for your career with 'Finishing Touch' workshops and a 16-week internship. # Programme Structure

The programme duration is a total of 12 terms over 4.5 years, with one internship period. You will be immersed in a rigorous curriculum that combines the best of both universities.

Throughout the academic years, you will be taking SUTD and SMU courses at both campuses - an integrated, interdisciplinary and multi-cultural learning experience, allowing you to interact more widely in both communities. You will have opportunities for overseas exposure. These include a study mission, student exchange and community service.

At the end of 12 semesters, you will graduate with a Bachelor in Business Management from SMU and a Bachelor in Engineering from SUTD with a major in one of three engineering pillars:

- Engineering Product Development (EPD)
- Engineering Systems and Design (ESD)
- Information Systems Technology and Design (ISTD)
